request for hearing, the Chancellor shall serve writtetince of the time and place of the hearing on the administrator. The date of the hearing shall be at a mutually convenient time, not less than 5 nor more than 15 working days after the receipt of the request for hearing. Upon the request of the adationisthre District at its own expense, will provide a certified legal recorder and a transcript of the proceedings for the administrator. The hearing before the Chancellor shall be for the purpose of providing the administrator an opportunity to respondot the reasons for the reassignment and to the recommendation of the appropriate Vice Chancellor. At the conclusion of the hearing, the Chancellor shall take the matter under submission and render his/her written decision and recommendation, if any, to the Board of Trustees within five working Days; a copy of the decision and the recommendation, if any, shall be served upon the affected administrator. Within five working days of the service of the decision, the administrator may serve on the Secretary to the Board of Trustees a written response to the decision and recommendation. The administrator may include in his/her written response a request for a hearing before the Board of Trustees. The Board of Trustees shall consider the administrator's written resonse to the decision and recommendation in making its determination as to whether to reassign the affected administrator. Pursuant to ECS 7241 1, an administrator employed by appointment or contract for a term longer than one year, shall have included in such appointment or contract a condition that notice that the administrator may not he employed in his/her administrative position for the following college year shall be given on or before March 15.

- II. For administrators who are required to be evaluated at once in every three academic vears pursuant to the Administrative Evaluation Procedure:
 - A.
